Chairman Goldson requests to see data regarding students that are on the cusp of the next tier.

Conclusion:

Dr. Stapleton provided the Board with his report. He began with his presentation of the NYS Regents Exams 2016 Pass Rate Comparative Data. Nassau County did comparatively well in regards to NYS. There was controversy surrounding last year's rate due to the speculations of a watered-down exam; which caused an exceptional number of students to pass. Our goal is to exceed the state's average. He explained that Living Environment, US History and ELA scores were not required for the results we are looking for, therefore not shown. Regarding the Student Growth Percentile, it is reported every year. The Growth Percentile makes up 20% of a teacher's overall score. The first tests were given in September. Results shown for grades K-2 indicated low Math scores. This was due to material being tested that hasn't been taught. Chairman Goldson raised a question concerning the big variance in the scores within a grade. Chairman Goldson highlighted that in one second grade class, both ELA and Math scores are high, reflecting a possible correlation that other teacher(s) may be weak in a certain subject area. Dr.

Stapleton assured this will be worked on in the near future. The Interim Assessment Data was presented by Mr. Phillips. He stated that these tests are given every year at this time. Chairman Goldson asked, "Why is there not an increase in scores all across the board?" Mr. Phillips says that it is due to the changes within students as they grow. After a brief discussion, a prevailing issue is that students know this is not a "real" test. Chairman Goldson admonished to push and reinforce that every test given is a "real" test. Chairman Goldson thanked Dr. Stapleton for his report.

Mr. Holloway provided the Board with his report. He reports that as tests have just been administered, he will provide the scores at the next Board meeting. Currently, there is still an opening for a Spanish teacher. An adjustment has been made to the curriculum whereby scholars have been given an Art course in lieu of Spanish. On January 21, 2017, the High School met with parents of 8th and 9th grade scholars. The two major topics of concerns were the communications being sent home with students regarding Saturday Academy and information regarding the High School.
