SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. In June 2021, the Chief Academic Officer convened a meeting with the various principals as a group to discuss how the monies will be spent for instructional purposes based on the needs of the students. Principals then met with the school level teams including teachers and support staff to solicit their input. Stakeholders were informed via the information in an ARP-ESSER PowerPoint presentation placed on a link on the school's website; comments were to be forwarded to the Chief Academic Officer. The consensus from the various stakeholders were as follows:

- Increased instructional time for targeted population including special educational and English Language Learners, and struggling general education students. This include summer school, afterschool, Saturday School, and special programs during the Winter and Spring breaks.
- · Provide continuous Social and Emotional Learning Support and related activities for students
- · Increased ESL/ Bilingual staffing

The Chief Academic Officer engaged the administrators including the special education and ESL directors, principals and assistant principals in various discussions related to the allocation of funding allowable as indicated in the guidance documents. Several face to face, and zoom meetings were conducted related to the need to address academic loss resulting from the Covid-19 pandemic. Moreover, the end of year student assessment data including *Renaissance* STAR (K-8), and course grade (9-12) from each school was used to determine staffing needs. We also discussed and reviewed the education literature to garner information related to the need for students' mental health and social/ emotion learning needs. Each principal conducted faculty meetings to inform school level staff about the availability of the funds and to solicit their input by discussing the resources needed by the students. The Chief Academic Officer and the Chief Financial Officer discussed and solicited input in scheduled Board of Trustees committee (Academic Committee, and Finance Committee) meetings. The information was shared with parents via a presentation posted on the school's website, and oral comments gleaned from parents related to the items on the agenda discussed in public Board meetings. The Chief Academic Officer also met the Parent Teacher Organization (Executive Committee) virtually to solicit parent input. Members of several community-based organization including the *Police Athletic League (PAL)*, the *Hispanic Counseling Center*, and *100 Black Men of America* also met with the Chief Academic Officer to discuss the extended-time learning opportunities such as Summer School and After School programs schedule and focus. In order to keep stakeholders engaged, the school will focus on scheduled meetings to discuss progress as follows:

- Faculty conferences Monthly
- · Board of Trustees Meeting reports Monthly

The Academy Charter School has developed and fully implemented Mitigation Protocols consistent with CDC guidelines and Nassau County Department of Health. Our actual Protocols address all of the following topics in much detail:

- · Social Distancing
- · Use of PPE and Face Coverings
- Operational Activities for all school facilities, for example: new air filtration systems in all school facilities, contactless water fountains, all restrooms will be cleaned hourly
- Hygiene, Cleaning & Disinfection
- · Extracurricular, for example: Phys Ed classes, Music and STEM will follow CDC guidelines
- · Before and After Care of infected school community members
- Transportation of students
- · Food Services provided by our school
- Mental Health, Behavioral & Emotional Support Services & Programs
- · Response & Communication with the school community
- Contingency Considerations

We will use ARP-ESSER funds to purchase & install a Diesel Generator to ensure that the Food Services provided by our school to our students during any short-term or long-term closures will not be interrupted during power failures. This generator will also ensure that the food service equipment and the Air Purifiers that we purchased with our ESSER 2 grant funds, will continue to function during both short-term and long-term power outages while in-person instruction is occurring.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The school will administer the *Renaissance STAR* Reading and Mathematics assessments system wide for all students in grades K-8. There will be three data points as follows: Beginning of Year in September, Middle of Year in January/ February, and End of Year in June. Student progress will be monitored using the beginning of Year baseline compared with the Middle of Year, and End of Year *Student Growth Percentile (SGP)*. Moreover, during the school year, students in grades K-8 receiving academic intervention services during the school day will receive progress monitoring every eight weeks utilizing the STAR assessments. Students enrolled in the summer school program will be administered the *Rally Education* English Language Arts and Mathematics assessment at the beginning and at the end of the four (4) weeks scheduled program. Moreover, students enrolled in the afterschool program will be assessment monthly using the *Curriculum Associates I-Ready* English Language Arts and Mathematics assessments. In grades 9-12, students receiving academic intervention services during the school day will be placed utilizing the *MWEA MAP* English Language Arts and MAP assessments. The beginning of year screening assessments will be administered in September, and the end of year assessments in June. Students will receive monthly progress monitoring assessments. Students will be assigned to after school tutoring based on their performance on the NWEA screening exams and their teacher/ departmental exam course grade in core academic subjects (English, Mathematics, Science, and Social Studies). Students enrolled in the six (6) summer school will be placed based on their performance on the *June Regents* exams. Students Scoring below 65% will be given the opportunity to retake the *August Regents* exams. The passing score will determine their progress.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The school will use the funds to create additional learning opportunities to make up for learning loss during the Covid-19 Pandemic. Much of the resources will be allocated to pay the salaries of teachers during two years of summer school. The school will utilize achievement data to target specific populations and sub-groups including struggling general education students, English Language Learners (ELLs) and Students with Disabilities (SWD) to participate in these programs. The overall focus will be as follows:

- Language Acquisition ELLs
- Social and Emotional Learning SWD, All Students
- Literacy Instruction (K-8) Reading and Writing
- Math Instruction (K-8)
- Core Content Instruction (9-12) (English, Mathematics, Science, and Social Studies)

Moreover, additional staffing for bilingual instruction will be hired to work with students during the regular school day.

- Purchase 30 Laptop Computers for Teachers & Teaching Assistants that will aid in regular and substantive educational interaction between students
 and their classroom instructors that serve low-income students and students with disabilities.
- Purchase 3-year Accidental Damage Insurance for the 30 Laptop Computers.
- Indirect Costs that are necessary to maintain the operation of and continuity of services in our LEA and to help us defray the costs of proper and efficient performance in the administering of our ARP-ESSER funded program.

The school will keep logs of the services provided to students. This will include detailed student attendance and the type of services they receive. Personnel (teachers and guidance counselors) will be required to keep daily log of student attendance. School administrators (principals, assistant principals and directors) will be required to provide weekly reports to the Chief Academic Officer. The Chief Academic Officer will present written and oral repots to the Board of Trustees. Overall, the Chief Education Officer will ensure oversight of the program including monitoring and compliance for the purpose of accountability. The desired outcome must result in increase in student achievement and social emotional growth. The school will target specific sub-groups of students for services by using student achievement data, special education referral data, 504s, and student discipline data to identify students for specific programs. The data will be reviewed periodically to measure progress and make adjustment based on the need of targeted populations. The data will include the annual New York State assessments such as the NYSESLAT, 3-8 English Language Arts Assessment, 3-8 Mathematics Assessment, and Regents exams. In-house data to be used will include the *Renaissance* STAR (K-8), and course grade (9-12). Data collection will also include anecdotal and written reports from teachers and support staff who regularly interact with specific students. Programs and services will be determined based on the needs of all sub-groups and targeted population, specifically students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students as identified by quantitative and qualitative data.
