May 2023 Report CEO and Founder, Bishop Goldson

Presenter: Ms. Felicia Barracks

- PR relations have expanded. Bishop Goldson and Mr. Haughton have been meeting with politicians, newspaper publishers, radio personalities and national activists. They have also met with senior charter school operators with hedge fund relations with the intent to foster these relationships and bring awareness around the schools.
- Engaging real estate developers for future extension plans.
- Charter renewal Focus will be on a specific component of the Mission Statement "Lead".
- Graduations start next week (week of June 19) across campuses with the first being Hempstead, HS on June 19. The Guest speaker, Congressman Tom Suozzi.

- Submitted copy of annual report of Charter authorization previously referred to as dossier.
- This document summarizes the school's annual performance.
- The Academy is still ranking as one of the leading Charter schools in NYS.
- NYS is in the process of redeveloping computative measures because of what was observed during COVID.
- Regarding our charter renewal the deadline is August 15.
- Summer school will run for four weeks for scholars Grades 1-8 who need additional assistance in math or ELA.
- Some scholars will retake the Regents in August.
- Pre-Service for new teachers begins August 21-September 1.
- Pre-service for returning staff begins August 28.
